

PUBLIC COMMENT: This item was discussed after item #8 on the agenda. Stephanie Robbins was present to discuss commercial vehicle parking in residential neighborhoods. She said there are two commercial vehicles parked on Harvard Drive that are of concern to her. She feels the ordinance for this needs to be updated.

 - B. NEW ITEMS:
 - 1) Sign Variance Request for 6274 Goshen Road – Culvers – This corresponds with the remodel of the store. They would like to replace signage on the south side of the building. There was a change in the sign code in 2008 eliminating signage for areas that are not adjacent to the street or directly adjacent to off street parking. The sign that was there became grandfathered non-conforming use. The current code does not allow for signage to go back in that current location. Mark Wessell of Springfield Sign was present to speak on behalf of the applicant. Motion to approve (Morrison), seconded (Krause) and voted 1 aye (Risavy), 2 nays to forward to Council.

- 2) An Ordinance Amending Chapter 22 of the Codified Ordinances of the City of Edwardsville (Sidewalk Dining) – The license fee was revised. It eliminates the \$100 fee and updates the liability insurance requirements for businesses wishing to allow sidewalk dining. Motion to approve (Krause), seconded (Morrison) and voted all ayes to forward to Council.

- 3) An Ordinance Amending Chapter 114, Article II, Division 5 of the Codified Ordinances of the City of Edwardsville (Left Turn Prohibited) E. College at N. Main – This originated out of Public Safety about 2 weeks ago following a pedestrian collision that occurred. This ordinance will restrict left turns at the intersection of East College Street and North Main Street (Westbound East College to Southbound North Main). Committee discussed how the flow of traffic would be with this change and alternate routes that could be used. Motion to approve (Krause), seconded (Morrison) and voted all ayes to forward to Council.
