The regularly scheduled meeting of the Edwardsville City Council was held at 7:00 p.m. in the Council Chambers of City Hall, located at 118 Hillsboro Avenue in Edwardsville, Illinois, with Mayor Patton presiding. Aldermen Risavy, Morrison, Krause, Farrar, Louer, Stack and Burns answered present on roll call.

The Pledge of Allegiance was recited by all present.


