

**ORDINANCE NO. 6664-09-2020**

**AN ORDINANCE AUTHORIZING THE SALE  
OF CERTAIN PERSONAL AND GOVERNMENTAL PROPERTY**

**WHEREAS**, the City of Edwardsville is a home rule unit of government pursuant to Section 6(a), Article VII of the 1970 Illinois Constitution and as a home rule unit may exercise any power and perform any function pertaining to its government affairs; and

**WHEREAS**, certain items of personal and governmental property owned and/or legally controlled by the City of Edwardsville become surplus or obsolete; and

**WHEREAS**, when personal property is no longer necessary or useful to the City and the continued ownership and control of said property is not in the best interests of the City; and

**WHEREAS**, it has been determined by the Corporate Authorities that property not to exceed the value of \$10,000 shall be sold or disposed of in the manner that the appropriate City official deems to be in the City's best interest and not wait to accumulate property for a large public auction.

**NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF EDWARDSVILLE, MADISON COUNTY, ILLINOIS**, as follows:

- A. That the surplus personal property of the City be sold at public or online auction or by sealed bid;
- B. That the appropriate City officials are authorized and directed to publicize said sale, and to prepare and marshal that personal property for such sale, and to execute and all bills of sale or certificates of title as may be appropriate to the property so sold;

C. That the appropriate City officials are authorized to retain the services of an auctioneer and customary assistants or authorized online auction services for the sale of the property.


