



The RP Lumber Center Membership Agreement

Membership Agreement

This Membership Agreement (“Agreement”) is entered into by The City of Edwardsville and (“Member”), and comes into effect as of _____.

1. Member Benefits

As of part of membership with RP Lumber Center, the Member will receive the following benefits:

- Unlimited admission to all schedule public sessions (skate rental not included)
- Unlimited access to indoor track and fitness center
- Member only registration opportunities
- Member only special events
- Member discounts on stick and puck sessions, adult pick up sessions, freestyle session, birthday parties, adult hockey leagues, youth hockey leagues and programs and room rental

2. Membership Dues

Membership Type:

District 7

- Family - \$40 per month**
- Individual (18-64) - \$30 per month
- Youth (4-17) - \$18 per month
- SIUE student - \$18 per month
- Senior (65 plus) - \$20 per month
- Senior Couple (65 plus) - \$30 per month

Non District 7

- Family - \$60 per month**
- Individual (18-64) - \$45 per month
- Youth (4-17) - \$27 per month
- SIUE student - \$18 per month
- Senior (65 plus) - \$30 per month
- Senior Couple (65 plus) - \$45 per month

*\$40 enrollment fee (one-time fee, unless membership is discontinued for more than 30 days)

**Family membership is up to two adults and # dependent children under 26 living in the same household

Payment Options:

Monthly Bank Draft

- Monthly payment is automatically deducted from your checking/savings account or credit card/debit card. Payment is drafted on the 15th of each month. All membership fees are non-refundable. In order to change or terminate the monthly bank draft plan, I must provide the City of Edwardsville with 7 days written notice on or before the 1ST of the month. If member's payment is unable to draft, member will be responsible for that payment, a \$15 returned fee and any other recovery fees.
- These fees are in addition to any service fee members bank may charge. It is the member's responsibility to check their bank/credit card statement and report any discrepancies within 30 days of the draft in question.

Annual Payment Option

- Annual plan is available for all memberships. Fees are equal to 12 monthly payments. Annual memberships are non-refundable. Payments can be made by cash, check, or credit/debit card. Membership expires 1-year from date of purchase.

3. Restrictions

The Member agrees not to:

- Share their login information with non-members
- Reproduce any of the information received as part of their membership and share it with non-members

4. Membership Termination

The City of Edwardsville has the right to terminate the Member's membership if any of the terms and the conditions of this Agreement are violated. The Member may terminate their membership at any point and for any reason and will not be charged for their next billing cycle. In order to change or terminate the monthly draft plan, I must provide City of Edwardsville with 7 days' written notice on or before the 1ST of the month.

5. Blackout dates

Member understands that certain areas of the facility, including, but not limited to the teen center, track, and fitness center may be subject to temporary closure for designated or private events. City of Edwardsville staff may provide reasonable notification to its members.
