This Agreement (“Agreement”) is entered into by The City of Edwardsville and (“Member”), and comes into effect as of _____.

1. Facility access

After school student membership includes access to the following areas within the RP Lumber Center:

- The Garage Teen Room and Patio area
- Lower level lobby area
- Study Room (Study room is scheduled on a first come, first served basis. Depending on demand, reservation time is limited to 60 minutes. Occupancy limit is 8 persons)

Student memberships are restricted from access to the following areas:

- Fitness Center
- Upper Level lobby area
- Track
- On ice
- Community rooms
- Locker rooms
- Rink player benches and penalty boxes
- Rink Bleachers
- Staff offices
- Zamboni room
- Staff-only areas (behind front desk, behind fitness center desk area, behind concession stand, back of ice rink)

2. Facility Rules and Policies

- a) Everyone must check in at the front desk.
- b) This facility is a family-friendly environment. We ask that you dress appropriately at all times and avoid the use of foul language.
- c) Zero tolerance policy. No alcohol, smoking or vaping.



- d) No outside food is allowed.
- e) Bicycles, roller blades, skateboards, scooters or pets (trained assist animals excluded) are not permitted inside the recreation facility.
- f) The use of student areas within the RP Lumber Center is a privilege and participants are expected to be good citizens and respect the rights of others. Individuals who engage in unacceptable or irresponsible behavior may have their access to facilities revoked or modified indefinitely.
- g) Alcoholic beverages and anyone under the influence are prohibited.
- h) RP Lumber Center and the City of Edwardsville are not responsible for lost or stolen items.
- i) The use of audio devices is restricted to staff. Please use headphones/earbuds to listen to your audio content.
- j) Verbal or written abuse, threats, intimidation, violence, or other forms of harassment toward patrons, participants, or staff will not be tolerated.
- k) Violators will be required to leave the facility and may be subject to disciplinary action such as but not limited to expulsion from the facility, suspension of the use of the facility, and trespassed indefinitely.
- l) No jumping on furniture.
- m) No rearranging of furniture without staff consent.
- n) We reserve the right to refuse play and or service to anyone who does not comply with facility rules and policies.
